Consequent upon the conclusion of various rounds of counselling for admission to M.Sc. Nursing Courses-2026, a number of seats have remained vacant. In order to fill up those seats, fresh Applications, in prescribed format (**annexed as Annexure-A to this Notification**), are hereby invited from the eligible and desirous candidates for seeking admission to M.Sc. Nursing Courses - 2026 in the Pvt. Colleges/Institutions of UT of J&K for the academic year 2026. The selection of the candidates shall be governed by the J&K Board of Professional Entrance Examinations Act, 2002 and the Rules and Regulations there under; the Jammu and Kashmir Reservation Act, 2004 as amended vide J&K Re-organization Act, 2019 and the Rules there under as amended vide SRO-518 of 2019 dated 02-09-2019, S.O. 249 dated 23-07-2021, S.O. 277 of 2021 dated 13-08-2021 and S.O.176 of 2024 dated 15th March, 2024 read with S.O. 305 dated 21-05-2024 subject to further amendments, if any, made by the competent authority, from time to time and guidelines as contained in the Electronic Information Brochure-2026.

Important Information

1. Submission of Application Forms/Preferences **shall commence w.e.f 06-08-2026 (11:30 a.m. onwards).**
2. Last date for submission of the Application Forms/Preferences: **10-08-2026(till 4:00 p.m.).**
3. Candidates who had not registered earlier and submit their Application Form/Preferences physically at BOPEE office Jammu/Srinagar shall deposit the counselling fee Rs. 1000/- (Rupees one thousand only) through POS Machine available at BOPEE office Jammu/Srinagar using their National Credit Card/Debit Card.

Eligibility

A candidate must

- i) be a domicile of UT of J&K;

- ii) have passed B.Sc. Nursing/ B.Sc. (Hons.) Nursing /Post Basic B.Sc. Nursing with minimum of 55% aggregate marks;
- iii) should have undergone B.Sc. Nursing/ B.Sc. (Hons.) Nursing /Post Basic B.Sc. Nursing in an institution which is recognized by the Indian Nursing Council;
- iv) should be a registered Nurse and Registered Midwifery or equivalent with any State/UT Nursing Registration Council;
- v) have a minimum of one year work experience after B.Sc. Nursing;
- vi) have a minimum of One year work experience prior to or after Post Basic B.Sc. Nursing;
- vii) Candidates shall be medically fit.

Documents to be Attached:

- i) Domicile of UT of J&K;
- ii) B.Sc. Nursing/ B.Sc. (Hons.) Nursing /Post Basic B.Sc. Nursing final year/semester marks card;
- iii) State / UT Registration;
- iv) One year work experience prior to after Post Basic B.Sc. Nursing or after B.Sc. Nursing;
- v) Any other documents, as required.

NOTES:

- I) During conduct of mop-up round of counselling for admission to M.Sc. Nursing courses-2026, the reserved category seats which remained vacant were converted to Open Merit in terms of Proviso to sub section 2 of section 9 of J&K Reservation Act 2004 which was followed by Mop-Up round. Hence, the willing candidates are hereby informed through the medium of this notification, that all the available seats are Open Merit seats.**
- II) The Application Form submitted is purely provisional and is liable to be cancelled at any stage subject to the final verification of the documents by the college/institution and even at any stage where such a document is proved to be fake/false.
- III) The submission of application forms/preferences shall not confer any right to such candidates for admission to these courses unless the eligibility is verified by the Board or Institutions where the candidate is provisionally selected.
- IV) The candidates who have already joined and are holding any seat shall not be eligible to participate in this round of counselling.**

Mode of Selection:

- i. **Firstly, the seat shall be allotted on the basis of Merit obtained in Common Entrance Test (CET) conducted for M.Sc. Nursing courses-2026.**
- ii. **Further, if any seat remains vacant, the same shall be allotted on the basis of aggregate Marks obtained in Qualifying Examination.**

- iii. In case of tie, the allotment shall be made as per the criteria mentioned in Point No. 12, Page No. 31 of e-Information Brochure of M.Sc. Nursing Courses-2026
